Booth spaces will be 10 x 10 - Please check if you will need 1 or 2 spaces . Artist must supply their own tents. Tents should be of professional quality. There is a \$125 booth space fee for a 10 x 10 space and \$250 for a 10 x 20. Electricity will be provided to each booth. We encourage you to stay open until at least 8:00 pm on both Friday and Saturday. All crafters are responsible for payment of applicable city and county sales tax – forms will be provided.

Please fill out the following information and return with **a picture/bio or press releases you may have. These will be used in promotions and media prior to the festival and by the Heritage Harbor Days Committee for selection. There will be a \$15.00 non-refundable processing fee to be sent with the application.**
